Limit 3 classes per horse. Tests will be ridden in a covered sand arena or outdoors in a fenced sand arena. A fenced outdoor sand arena will be used for warm-up. Protective helmets must be worn by ALL riders when mounted. Outdoor day pens (12' x 12') will be available. Snacks and drinks will be provided. Bring your own lunch.
